### **Reorganizational Meeting/Barry Town Hall**

**April 21, 2026 @ 7:01 p.m.**

Chair Ed Hattenberger opened the meeting at 7:01 p.m.

### **Reorganization of Township Fees, Designations and Policies**

#### **Appointments**

Al Moon made a motion to make Ed Hattenberger Chair, seconded by Kim Crow and unanimously approved.

Chair -

Appoint personnel supervisor – Ed Hattenberger

Appoint road supervisor – Al Moon

A motion was made by Al Moon to accept the nominations from the Chair, seconded by Kim Crow and unanimously approved.

#### **Wages –**

Chairman - **\$75** regular meeting

Supervisors - **\$75** regular meeting

Clerk - **\$25** per hour, **\$75** regular meeting

Treasurer - **\$25** per hour, **\$75** regular meeting

Deputy Clerk and Treasurer - **\$75**/for working regular meeting, **hourly pay \$20/hour**

Road supervisor - \$20/hour plus mileage

Zoning supervisor - \$20/hour plus mileage

Planning Committee Members - \$50/meeting

**Supervisors paid equivalent of one meeting for yearly road review**

Website Coordinator and meeting tech **\$20** per hour up to **10 hrs. per month**

Supervisor wages \$20 per hour **plus mileage for zoning and road inspections**

Election judges - **\$20/hour plus mileage**

Head election judge - **\$22.50 plus mileage**

Clerk's election wages – **same as hourly pay**

Election judges, head judges, clerk – **paid for required training time and mileage if they work for all Barry Township elections**

**Motion to set wages as listed** was made by Kim Crow, seconded Ed Hattenberger and unanimously approved.

#### **Fees**

Mileage – current federal rate

Mower – quotes for cost

Town Hall Mowing – Ed Hattenberger will mow and keep the hay as payment

Photocopies, time and mileage – requested copies of minutes, etc., 50 cents for one-sided copies, \$1 for two-sided copies. Copies, time, mileage estimated at \$50 or more must be paid in advance. (The township is a non-data practices body and not required to supply copies at township meetings)

Site permits - \$75

Conditional use permits – As required according to the permit

Interim use permits - As required according to the permit

**Motion to accept fees** was made by Ed Hattenberger, seconded by Kim Crow and unanimously approved.

1. Culvert policy – The board will design the culvert policy. Minimum culvert size 16 x 30 (as prescribed by supervisors) Fee for a driveway culvert permit - \$75
2. Mailbox policy will copy Pine County's policy – Twp will repair

3. 1. Snowplowing Policy- Plowing of the Township roads with be done at the direction of the Board of Supervisors.

A motion to accept policies 1-3 was made by Ed Hattenberger, seconded by Kim Crow and unanimously approved.

4. **Motion to accept the following regular reaffirmed designations** – was made by Kim Crow, seconded by Al Moon and unanimously approved.

1. Hold the Board's regular monthly meetings on the third Tuesday of each month at the Town Hall, at 7 pm.
2. North Pine County News as official newspaper to print notices and post notices on the posting board at the Town Hall. Notice may also be posted on the Townships' website.
3. Northview Bank, Hinckley MN as the official depository.
